

Non-Discrimination Statement - Title VI

Title VI of the 1964 Civil Rights Act provides that no person in the United States shall, on the grounds of race, color, or national origin be excluded from participation in, be denied benefits of or be otherwise subjected to discrimination under any program or activity receiving federal financial assistance. SETDD is committed and fully complies with Title VI of the Civil Rights Act of 1964, and related statutes and regulations, in all programs and activities.

Making a Title VI Complaint

Any person who believes that they have been excluded, denied benefits, or been subjected to discrimination may file a written complaint to SETDD within 180 days following the date of the alleged discriminatory occurrence. The Title VI complaint should be sent to:

Grievance Procedure

Title VI

Title VI of the Civil Rights Act of 1964 requires that no person in the United States, on the grounds of race, color or national origin be excluded from, be denied the benefits of, or be subjected to discrimination, under any program or activity receiving federal finance assistance. This grievance procedure may be used by anyone who wishes to file a Title VI complaint alleging that he or she or any other program beneficiaries have been subjected to discrimination in his or her receipt of benefits and/or services from SETDD, or by a contractor or sub recipient on the grounds of race, color or national origin. These procedures do not deny the right of the complainant after completion of the Title VI complaint process to file a complaint with the state or federal agencies, or to seek private counsel for complaints alleging discrimination, intimidation or retaliation of any kind that is prohibited by law. This procedure applies to the CARCOG/Southeast Tennessee Development District (SETDD) applicants, participants, and service/training providers, and applies to all complaints where discrimination based on race, color, or national origin is alleged. The CARCOG/SETDD Title VI Coordinator will be available to assist in filing any complaint. Employee complaints will be addressed through procedures described in the CARCOG/SETDD Handbook. A Title VI Complaint Form may be found on SETDDs website or by contacting the Title VI Coordinator.

Local Complaint/Appeal Process

1. All complaints must be submitted in writing to the Title VI Coordinator at the Southeast Tennessee Development District Office in the form of a letter at the following address*:

All complaints must include:

- Name, address, and date of complaint
- A description of each allegation
- If there are any witnesses, their names are included
- Date of the incident (or time frame, if there is an occurrence over a period of time), and date of filing;
- Signature of complainant
- Complaints must be submitted within 180 days of the date of the incident
- The Title VI Coordinator will provide written acknowledgement of receipt of the complaint to the complainant.
- 3. The Title VI Coordinator will launch an investigation.
- 4. The Title VI Coordinator will hold a formal verbal discussion with complainant within 15 workdays of receipt of complaint.
- 5. The Title VI Coordinator will communicate a written decision to the complainant within ten workdays of the verbal discussion.
- 6. Should the complainant not be satisfied, the complainant may file a written appeal with the Executive Director of the Southeast Tennessee Development District.
- 7. The Executive Director will render a written decision to the complainant within ten working days of receipt of the appeal. If more time is required to reach a decision, the complainant will be notified in writing of the time by which a decision will be made.
- 8. If dissatisfied with the Executive Director's ruling, the complainant may petition the Executive Director for a hearing.
- 9. The Executive Director will appoint a committee and convene a hearing to hear the complaint. The hearing will be limited to the original complaint and the complainant can choose to be represented by another individual, including legal counsel.
- 10. The committee's written decision will be conveyed to the complainant within ten working days.
- 11. The decision of the committee may be appealed to the State.
- 12. Copies of all appeals will be forwarded to all necessary departments.
- 13. All files pertaining to complaints will be maintained not less than three years, and will be available to all federal and state monitors.

*Complaints alleging discrimination based on the grounds of race, color, or national origin may be filed by contacting the Title VI Coordinator at the Southeast Tennessee Development District, P. O. Box 4757, Chattanooga, TN 37405-0757, or by contacting an appropriate outside agency, such as Federal Coordination and Compliance Section-NWB, Civil Rights Division- US Department of Justice, 950 Pennsylvania Ave, NW, Washington, DC 20530.
